INSTRUCTIONS:

Who may apply for an early mail ballot?

Each person must apply for themselves. It is a felony to make a false statement in an application for an early mail ballot, to attempt to cast an illegal ballot, or to help anyone to cast an illegal ballot.

Where and when to return your application:

Applications sent by mail must be received at least seven days before the election, or hand-delivered to the Village Clerk up until the day before the election to 235 Lincoln Place, Westbury, New York 11590. If you have not received your early mail ballot by the day before Election Day, please contact the Village Clerk at 516-334-1700.

When your ballot will be sent:

Your early mail ballot materials will be mailed to you at least 6 days before the election in which you are eligible to vote. If applicant or agent delivers the application to the Village Clerk in person after the seventh day before the village election and not later than the day before the election, the Village Clerk shall deliver such early mail ballots to applicants, or their agents named in the application, when such applicants or agents appear in the Village Clerk's Office.
